Sub: Mandatory furnishing/ updating of PAN, KYC details and Nomination by holders of physical securities

Ref.: SEBI circular on ‘Common and simplified norms for processing investor’s service request’ dated 16th March 2023

Dear Shareholder,

As an on-going measure to enhance the ease of doing business for investors in the securities market, SEBI, vide its Circular dated 3rd November, 2021 read with Circular dated 14th December 2021 had prescribed common and simplified norms for processing investor's service request by Registrar and Share Transfer Agent (RTA) and norms for furnishing PAN, KYC details and Nomination.

Further to above circulars SEBI through its circular dated 16th March 2023 has mandated the following:

- a. PAN, KYC details (email address, postal address, mobile number, bank account details), specimen signature and nomination information are to be furnished by the holders of physical securities.
- b. Compulsory linking of PAN and AADHAR by all shareholders by 30th June 2023 or any other date as may be specified by the Central Board of Direct Taxes (CBDT).

Consequences of Non Updation of Details:

- a. The Company/ RTA will entertain a shareholder’s service request only upon receiving PAN, KYC details and nomination information.
- b. The folios will be frozen by RTA, if the documents and information as requested in (a) above are not available on or after 1st October 2023 or PAN is not linked to Aadhaar as stated in (b) above by 30th June 2023 or any other date as may be specified by CBDT.
- c. The frozen folios will not be eligible to receive dividend declared by the Company and/or (i) for lodging a grievance/service request.
- d. The frozen folios as on 31st December 2025 shall be referred by RTA/Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002.
